2. Madhyabindu Municipality invites bids from eligible bidders for the following Civil work. A complete set of Bidding Documents may be purchased from the Madhyabindu Municipality, Office of Municipal Executive, Chormara, Nawalparasi, Nepal, by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 3000.00 for bid document. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 3000.00. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

Bidders, submitting their bid electronically, should deposit the cost (as specified below) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.
