Minimum Work experience of similar size and nature: **One (1) Project** with a Value of **NRs. 4,04,00,000.00 .**

6. The bidders are informed to attach supporting documents to verify the Qualification Criteria.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **2075/09/03 ( 18<sup>th</sup> Dec, 2018) , 14.00** at the office of **Madhyabindu Municipality, Office of Municipal Executive, Chormara, Nawalparasi (B-S.E), Gandaki Province, Nepal.** Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of **Nrs. 12,65,000.00**, which shall be valid for **30 days** beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Each bidder shall bid only one bid, either individually or as a partner in a J/V. To facilitate contract administration, the number of partners in J/V is limited to three.
9. The bidders are advised to visit the site & assess the actual site condition before submission of bid document.
10. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
